# **RESIDENTS TO VOTE MAY 20th ON 2025-26 BUDGET**

# Dear Moravia Central School District Community,

We're pleased to share the details of the proposed 2025-2026 school budget in this newsletter.

This year's budget development process began with the challenge of substantial increases in fixed costs (e.g., healthcare at 10%), coupled with only a modest increase in state aid (2%). For the first time in several years, we had to make difficult decisions to close a "gap" of over a million dollars.

Reviewing the options, we began by analyzing current and future enrollment projections. The loss in state aid is predicted to be a multi-year fiscal challenge for small rural districts like Moravia. Following multiple discussions and deliberations, the decision was made to move to a two-building model with an elementary (grades UPK-6) and junior high school (grades 7-12) starting in the 25-26 school year. This building restructuring allowed for multiple cost-saving efficiencies to be utilized to position our district in the best possible fiscal situation moving forward.

With any change of this significance, there are challenges and opportunities presented, but our leadership team is committed to preserving the successful components of our current

programming. We aim to utilize this opportunity to reimagine and enhance how we support students during these pivotal years — providing engaging academic opportunities, meeting students' social-emotional needs, and creating a purposeful bridge to high school and beyond. This shift is about more than just grade levels—it reflects our commitment to enhancing academic opportunities, better aligning instruction with student readiness, and supporting smoother, more intentional transitions.

In addition to the budget vote, residents will consider a proposition to purchase three new 66-passenger school buses as part of our ongoing, cost-effective 8-year bus replacement plan. Voters will also elect three Board of Education members.

We believe this budget reflects a careful balance between providing exceptional educational opportunities and maintaining responsible fiscal stewardship for our taxpayers.

## THREE-PART BUDGET



**ADMINISTRATIVE:** Salaries and benefits, as well as all other costs to operate the district office and each school's main office and cover Board of Education expenses.

**PROGRAM:** Funding for all K-12 educational programs, including teacher and support staff salaries and benefits, BOCES special education and instructional services, interscholastic athletics and transportation.

**CAPITAL:** Cleaning and maintaining district facilities, including salaries, benefits, service contracts, utilities, materials and supplies, capital outlay projects and debt service.

## PROPOSITION 1: 2025-2026 Budget

That the amount of \$29,874,130 be approved for the 2025-2026 school year and the Board of Education of the Moravia Central School District be authorized to levy the necessary tax on real property of the district.

### **PROPOSITION 2:** Bus Purchase

RESOLVED, that the Board of Education of the Moravia Central School District is authorized to purchase and finance three (3) student transport vehicles, including necessary furnishings, fixtures and equipment and all other costs incidental thereto, and expend a total sum not to exceed \$474,500, which is estimated to be the total maximum cost thereof, and said amount, or so much thereof as may be necessary, shall be raised by the levy of a tax upon the taxable property of said School District and collected in annual installments as provided by Section 416 of the Education Law; and, in anticipation of such tax, obligations of said School District, in the principal amount not to exceed \$474,500 shall be issued.

# **PROPOSITION 3:** Powers Library

RESOLVED, that pursuant to Education Law, Section 259, the Board of Education of the Moravia Central School District is authorized to levy and collect an annual tax, year after year, separate and apart from the annual school district budget, in the amount of \$2,835.00, in addition to the current appropriation of \$97,335.00 for a total of \$100,170.00 annually, which shall be paid to the Powers Library and for the support and maintenance of the library; with this appropriated amount to be the annual appropriation until thereafter modified by a future vote of the electors of the Moravia Central School District.

### **POWERS LIBRARY VOTE**

Public Libraries within New York State have the right to place their levy proposition on the Board of Education's ballot for submission to the voters. Powers Library serves the entire community of the Moravia Central School District and can levy taxes to the community it serves. The amount levied by the library is separate and apart from the school district levy, however the funds are collected and held by the school district until the funds are submitted to the library. Libraries are only required to have a proposition on the ballot when they are increasing their annual levy. If a vote on an increase were to be defeated, the funding for the library reverts to the previous amount approved by the voters.

# **VOTER QUALIFICATIONS**

To be eligible to vote on the school budget and election, you must be a citizen of the United States who is 18 years of age or older and a legal resident of the Moravia Central School District for at least 30 days prior to the vote.

No prior registration is required. Voter qualifications are mandated in accordance with New York State Education Law.

NOTE: Voting inspectors reserve the right to check the driver's license of any voter to verify residency.
